# Policy Section 6323/6333/6343 – Coaching Licenses – Eric Landon

In order to keep up with the demand of coaching education, the recommendation is U9-U12 coaches would need an E-license or waiver (good for one season) for one or more teams. At U13 and above coaches need a D-License or waiver (good for one season) for more than one team. Assistant coaches can have an E-license in any age group.
