KOREAN TEAM DINNER

An U16 Korean Soccer Team (24 members) and 11 adults will be visiting Salt Lake the week of July 21, 1992. This is the work of Moon Won Ji, an employee of the State of Utah in foreign affairs. Moon is also an avid player and referee and he has 3 sons playing soccer within UYSA. This project has been 2 years in the making. The itinerary for the team is as follows:

The team will be staying in homes of Utah soccer players and coaches to get a real feel for "American Life".

It has been requested that the UYSA sponsor a welcome dinner for this group with possible attendance by the Mayor of Salt Lake and/or the Governor. This is not only a soccer trip, but also a show of good will to the Kyungi Province which is the Utah Economic Sister State in Korea from which this team is traveling. As well as a dinner, I have asked Paul to speak on behalf of the UYSA and we are working on getting Salt Lake/Utah dignitaries to take part and speak on behalf of their respective areas.

The proposed cost of the dinner ranges as follows: (Proposed 50 people)

The prices just go up from there to \$25 per person.

Other local businesses are sponsoring tournament fees and alternate jerseys for the team.

UYSA BID PROCESS

The proposal is as follows:

UYSA will create a "Vendor List" for all areas that require bids such as:

Office Equipment
ODP Uniforms and Equipment
UYSA Camp T-Shirts
Competition Age Group Winner Trophies
Etc.

All of these bidders will be contacted when a bid for their respective area is needed. 3 bids will be requested.

The bids will be written in such a manner that it will be very specific as to the needs of the UYSA and will allow for an easy decision as to whom the bid is awarded.

Bids will be presented at a meeting in sealed envelopes with the vendors present. At that time the bids will be opened and the bid awarded. All bids will go into a file for review at any time in the future.

SIGNING OF TRAVEL PAPERS AND "LATE FEE"

It has been proposed to charge a late fee for the signing of travel papers that are presented for signature less than 30 days before the proposed tournament. The fee amount has not been discussed.

U19 BOY AND GIRL MEMBERS FOR UYSA BOARD

A letter went out recently asking all competition coaches to nominate and vote for an U19 Girl and Boy to be non-voting members of the UYSA Board as decided at the February, 1992 AGM. Responses are expected soon.

UTAH SUMMER GAMES UPDATE

Utah Summer Games preparation is well on its way with almost 70 teams (U10 to Adult). It has been a major undertaking by myself, KRIS, MAURINE, and Billy, but well worth the effort. It is a very big "Shot in the Arm" for youth soccer and is a high profile sport in the Utah Summer Games that will receive TV exposure. Due to our involvement, I will be meeting with several people in St.George/Cedar City to discuss possible re-opening of the UYSA soccer issue in Southern Utah.

We hope to see you there and bring your Referee uniforms. Schedules are available if you wish to attend.

WORLD CUP '94 PLAYER LIST

There are only 4 remaining leagues that need to provide their player lists to us and we will be able to send off the whole package to the World Cup '94 Committee. After I have a chance to discuss the "SOCCER REGISTRATION" program with the appropriate people (in terms of getting the information off the respective computers in the correct format) this will happen real fast. That will mean \$\$\$ for UYSA in the near future.

REFEREE AND SCHEDULING PROGRAMS

I have received some information on "canned" programs that are available. Two more meetings are scheduled with people who can assist us in this area. After those meetings, I will provide a complete run down on the situation for approval. Mike Winn and Maurine Reynolds have been more than helpful on this project.

We were able to provide some good information, but we would like to encourage board, district and league members to participate in providing more information for this great form of communication within our soccer community. We had some interest in advertising in this issue which help offset costs, but in future issues the interest is much higher and we hope to make it self-sufficient in the near future.
