#### **Public Comment**

- Matt Rader update on new disciplinary chair. Andrea Bowers has stepped down, discusses current disciplinary issue between Utah clubs.
- Bryan Attridge provides an update with an updated partnership with Stack Sports
  - Updates w/ Stack
    - Integration with referee platform
    - Club level platform to organizations to use and upload to Association level
- Matt Rader updates the board on Covid Protocol
  - Fully vaccinated coaches do not need to wear masks
  - Recommends coaches to wear mask if they have not been fully vaccinated
  - Still ask players to social distance

- 6324 & 6354 Club Passing
  - Cindy introduces the why. Thought the +2 would do the trick, but clubs do not feel that way.
    - Explanatory note add "can only go down within their respective league"
    - Go into effect Fall 2022 seasonal year
    - Board members would like to hear the comments from the competition committee before this goes into the business section of board meeting
    - Make sure it is specific with uniform language
    - Brian Babcock would like to include PDC and CS on it

### **Business**

- 1411 OM & Club Passing
  - A club development plan would be provided and approved by the state technical director prior to the OM being able to utilize the club pass if the organizational member intends to utilize the club pass.
    - Initial deadline is to submit by Jan 1 for the tech dept to review the club development plan
    - \*\*Reapplication section of policy (1412) would need to be modified to require implementation
      - Add this into bullet point 6 for September board meeting
        - Motion to Brian Babcock
        - o Seconds Toby Yoshida
        - All in favor
  - Eric continues to explain section of the developmental plan
  - Renata clarifies vision of this program is to have club leadership submit a plan to assess themselves as a club
    - Presentation just between club and UYSA or would it be published to members of club?
      - Club would have the purview to share with whoever they would want to
      - Renata likes the idea of it but comments on the level of work that it will take to get it done and submit it to the UYSA tech department
- 6.1 Probation & Bad Standing Definitions
  - Cindy explains how there a definition of "bad standing" has never been in policy. The point of this policy is to define both bad standing and probation.
    - Justin Harryman motions to approve
    - Brian Babcock seconds motion to approve
      - Add "Any OM in bad standing..."
      - Just have definition in this policy and plug in "Bad standing" into certain sections such as AGM, sanctioned tournament, league, etc.
    - Motion to vote Justin & Brian B
  - "Means that their respective membership rights are suspended......" Lose rest of policy and add it as we see fit in spots where bad standing applies
  - All in favor

- \*\*Brian motions to table it to come up with a more objective standard on what does a team is leaving mean (less than majority)....but it doesn't matter if it is a US Youth or non-US Youth
- Zig seconds motion
- All in favor to table to next board meeting

#### • 6315 & 6317 Forfeits

- Cindy reviews enhanced concepts
- Zig motions to approve with the modification of \*\*changing "spot" to "one division"....and the understanding that Scot will update Spot in other parts of policy and change to division
  - \*Bond goes to the team that was forfeited ON
- Brian B seconds motion
  - Create a definition of application league
  - Remove shall from bullet point 1 to may
  - Toby requests to define where the bond goes
  - Consistent grammar (upper case)
- Friendly amendment Renata to add another bullet point "If a team has more than
  2 major forfeits shall pay an immediate fine of \$500 per infraction"
- At the discretion of the League Commissioner
- A team that has 2 major forfeits shall be placed in bad standing
- \*\*\*Shall be dropped two spots in the standings at the end of the season
- Brian B asks to table it and vote on it in an email vote
