Because of some issues that have come up during league play all members of the Board, Committee Chairs and Staff need to remember that as the Leadership of UYSA we are held to a higher standard of conduct. Sidelines and others that we work with in the community are watching our actions. Please remember that we need to set the best example and have the conduct in the soccer community. Reminded everyone that no pass means no play and that referee's do not have the authority to set aside the rules of play that UYSA has in place. Spring State Cup is under way and that it is going well. Bruce Cuppett's wife is gravely ill and requested that we keep the family in our thoughts and prayers. Region Director, Jolene Nielson's son has passed away.

ACCEPTANCE OF MINUTES

Motion was made and seconded to approve the minutes from the April 15, 2010.

NEW BUSINESS

RECREATION PROGRAM FEES

The state has lowered their fees to \$9. Some districts have increased their fees. Districts please review and make sure you are charging fees based on services you are offering so the programs can be competitive.

STATE REFEREE ADMINISTRATOR

Gus Colessides will be stepping down as the State Referee Administrator. Scott Harward will assume the role of State Referee Administrator.

NOMINATIONS FOR COMMITTEES

Each district should have mirrored committees to handle district issues at the district level and then when items need to be escalated, can move to the state committees. Committees need people to help on the state level and would benefit the committees with training on the district levels. Typically committees meet once every 3 (three) months. Discipline Committee is busiest during the season.

CODE OF ETHICS

Coaches, players and parents have the UYSA Code of Ethics. Look at adding the Code of Ethics for parents to agree to when they register players online. As members of various UYSA boards, we are held to a higher standard and should know the Code of Ethics, policies, bylaws and follow them as role models for the organization.

SPONSORSHIP AND MARKETING

ReAL Salt Lake has proposed to work directly with UYSA to co-operate in sponsorships and marketing ventures. Scott Dunkley will be asked to chair the committee. UYSA will figure out the value associated with this opportunity and if it has long term financial merit.

COACH LICENSE POLICY

A proposed revised Coach License Policy was handed out for review. UYSA will be clarifying the current policy at the next board meeting.

PERFORMANCE MEASURES FOR STAFF

UYSA HR committee will be setting up performance standards for the UYSA staff.

OLD ITEMS/ACTION ITEMS

DISTRICT REGISTRAR PROPOSAL

Proof of Age documents are indicated on the state site on the roster with a circled B next to the registered player's name. The state is working towards getting away from carrying proof of age documents by having the information digitally stored and accessed through the secure data base. The goal is to have all competition in the system this year. The goal is to have all registered players in the system, starting next year, x-league then recreation in the system. District Chairpersons felt that their District registrars would need to consult with them if they felt that they needed additional payment for the extra time that this would require.

BUDGET

Executive Director, Andrew Hiatt, could not attend. The budget was presented for review and will be voted on at the next board meeting. Please review and send any questions to Drew or Cindy.

TRANSFER POLICY

The transfer policy was reviewed with a motion to modify 3:07:02 to allow sanctioned, intra-club transfers outside the transfer window. Motion made to amend and passed to add "none of these restrictions shall apply to transfers within an affiliated club." "Please note any intra-club transfer will

count towards the limit of 5 found in 3:05:02". Separate email will be sent with final version of Transfer Policy.

An additional motion was made and passed to add U11 and U12 to the State Cup competition effective June 1, 2010.

CONTRACT UPDATES

ADG (Affinity) has asked for UYSA to sign an extension of the original contract. Changes and updates are needed to make the system more efficient for UYSA. The referee module still needs refinement including removing the viewable comment box to coaches so the referee's and coaches have separate comment areas. There have been situations where games have dropped off the system and the referee assignor could not put game into system. The module needs to make it possible to open and put a game into the system so the referees can be assigned and the game reported when this occurs.

Adidas/Score Sponsor Apparel Contract

Executive Director, Andrew Hiatt, worked hard with the vendors to get the best proposals for the upcoming contracts. Contract specifics were presented. Motion made and passed to have Adidas as the official sponsor for UYSA.
