#### **Study Session**

#### U10 and younger- registering for Academy & Rec

Bryan discusses the option to have recreation players or academy players be able to play both programs. If the academy program is being run like a camp then could recreation players register for both? Board discusses options. If an academy program is run like a camp (register in event manager), then a player who is not playing another play type could not register for the academy program because they would not be covered by the insurance. Drew suggests we dig a little deeper into the policy and get more information about the change in this. Discussion tabled until conference call before June.

## Field Dimensions U9 (tournament committee)

Orden suggests extending field sizes for U9 age group. Board of Directors gives autonomy for Tournament Committee to make fields sizes fit their needs. If we use the minimum amount then everything had to be reduced by two feet.

## **Rescheduling Fee**

John discusses the cancelling/rescheduling process. Competition sub-committee discussed at their May 2014 committee meeting the process of rescheduling and implementing a two week rescheduling

window where all games will be rescheduled during that window. Committee also discussed implementing a fee for rescheduling outside the rescheduling window. Fee will go to a UYSA fund applied to a referee training fund, field grant fund, and college scholarship fund. Implement a 4 business day rescheduling time opposed to the 72 hour rescheduling process. Schedule released 3 weeks before season starts. Give teams 2 weeks to reschedule all games for the season.

Discusses his research of Latinos and refugee players a part of Utah Youth Soccer. Explains how Salt Lake FC works with Taylorsville Youth Soccer to share fields. Discusses how other clubs have come in to use the fields they were using and other clubs are recruiting players

Business side and community side of soccer. When we allow clubs to be a business, we lose the concept of soccer

Drew suggests to invite RSL Academy admins to present to the board the plan of the academy program. Kyle motions to grandfather the team into their current alignment place. Work with the academy directly to get the team to be in the best place for the team.
