Registration.

Looking for a way to stop teams from swapping cards between teams in the clubs. Would like to make sure that the birth certificates on line have a limited number of people that can view them. Dist 2, 3, 5, 4 are working to get them on. ADG is looking to limit access to who can upload and view. How do coaches get copies for out of state tournaments? The region presidents are in favor of not using b-cert and a travel roster. In region play you would only need state cert roster. Not sure what the status of the update is. All instate tournament should not require the birth certificates. New district registrar in district 2 Susan.

All tournaments should start using the lighting detection. They are relatively inexpensive.

Kohls cup went well. 68 teams up from 40. The last week just before the start date Debbie received a lot of calls and could have doubled the number. Drew helped with the schedules, and things went well. The ADG system worked well, Drew attended the tournament and handed out goodies. All tournaments can use the scheduling system if they take to Drew.

ADG will start doing web x sessions for the training of both registration and tournament scheduling.

District 5 feed back feels that having no specters at any game would be to far reaching. The idea was to have the parents self policing. The refs feel that a single spectator the other parents are reluctant to address the unruly parent. What about making the parents required to take anger management class. Clubs should be policing their parents. How can we monitor the referees' actions? Can we better enforce the rules that we have in place? State ref committee is doing additional training beyond the standard recertifications – the refs would like to have a camp and training at one or more of the tournaments this summer. Norm will be following up with the mentoring to help with the sideline behavior. -

Delete the side line clearing and increase the red card dismissal to 2 games for the coaches. The coaches should not be at the next game at all just not in the tech area. If the coaches attend the next game then maybe we add additional games.

The development players should supply rosters to the refs and the opposing coach. Monday July 27, and Thursday July 30. No teams will play up U-15 and up – no play up.

NEW business:

Firebirds are still in a 1 year contract with say. Risk management is an additional \$10 per person. With registration, risk management, scheduler, included they will plan on coming back to UYSA in the fall of 2010. Try to do an article about them coming back.

District 6 will bring the comp fees in tomorrow and dist 2 will get caught up. Southern Utah is still about \$6,000 out standing. Fees collected should be above last year. Miscellaneous entry fees of \$55,000 – is to come out of state cup entry fees.

Davis High will be the band that will carry the state banner in the parade.

Business – action items

Recreation fees – Scott H. proposed to reduce the recreation player fee from \$11 to \$9 per player.

Total amount spent per player is about \$7.50

About 18,000 recreation kids with a loss of about \$36,000

The insurance has just come down with the new contract. US youth soccer was planning to increase fee because of loosing their key sponsors.

Working on a sponsorship – company will purchase a ticket for all recreation kids to a Real game.

Scott proposed to make this fee take place now as reduce the recreation fee from \$11 to \$9 starting in the 2009-2010 season.

The State should advertise the price break.

Motioned 2nd No other discussion Motion accepted – none opposed. Drew indicated that the budget will be adjusted to reflect the difference in collected fees.

Motion made to charge a team fee not a player fee for the competition teams as follows: U9 - \$200

U10 - \$250 U11 - \$275 U12-U15 - \$350 U16-U19 - \$400

All fees are per playing season – fall and spring.

State will collect per team and not per player as in the past. This will help to simply the accounting at the state level. The registers are in favor of this fee structure. The average number of players per team was questioned. Drew will re-look at the team averages and make adjustments to the above proposed fees based on what he finds.
